## **Employee Certification and Training Works**

Klickitat PUD (KPUD) makes an effort to train, refresh and certify its present employees and new hires. All KPUD employees are required to maintain current first aid, CPR and AED training, in addition to job-specific certifications and training.

The linemen in our operations department just renewed their annual explosives license, which requires that they have 16 hours of training a year or the equivalent number of hours on their blastingshot record.

They also maintain their flagging and forklift certification and CDL licenses. The linemen rotate through annual training classes. Recently, some of our linemen attended underground fault locating, transformer hot sticking, vectoring, rigging, chains and inspections training.
